# **ERASMUS AND INTERNATIONAL STUDENTS FAQS**

- 1. When do online classes begin? The 26<sup>th</sup> of March of 2020.
- 2. With which tools will I be able to join online classes? With video conferences on the virtual campus.
- Until when are classes going to be online? Until the Spanish government gives the go ahead for face-to-face classes to resume.
- 4. It is difficult for me to return to Spain considering the current situation in Spain and in my home country. Would it be possible to continue my classes online even if the situation improves and face-to-face classes resume in Spain?

Online classes are a temporary alternative to not being able to meet face-to-face. Face-to-face classes would resume if the situation allowed it.

# 5. Can I take the exams online?

Exams are not contemplated online. Other options like video conferencing would be considered only in the case that they could not be taken face-to-face.

- 6. What happens with continuous assessment? Will it also be available remotely? Continuous assessment will also be available online.
- 7. Would it be possible to take May exams in my Home University if I am not able to take them online?

8. What happens if my Home University is closed during the May call? What solution could you provide?

9. Are there any date changes related to June recovery exams of the exams calendar published in the virtual campus?

Unless the education authorities decide otherwise dates have not been changed at the moment.

**10.** What solution could be provided if my university is closed and I cannot go to Spain? Other options like video conferencing would be considered only in the case that the exams could not be taken face-to-face.

#### 11. What happens if I give up my mobility?

Giving up on mobility means having to take the exam of all the unmarked pending subjects as a DEX student and the incorporation could happen at any moment. Priorly, a notice of resignation should be delivered to the International Offices.





# 12. Would I have the right to apply to another mobility program the following year?

If you have taken a semester you can request another semester the following year. The same applies in case of resignation to mobility, but only the 2<sup>nd</sup> because of call deadlines.

### 13. Would I still receive the scholarship if I returned to Spain?

It can be considered as a period of mobility if you continue studying in the Host University through online courses.

#### 14. Will I be able to take my Host University's exams here in Spain?

If the Host University required face-to-face exams you would be able to apply to take them in Spain. This will depend on the Host University's policies in this matter.

**15.** My university has delayed the course start date and now it ends in August, would it be a problem if I arrived later for the start of ESIC?

It would not be a problem; late incorporation would be taken into account.

#### 16. Will validations remain the same despite classes being online?

According to your Learning Agreement, grades that correspond to the Host University's courses will be transferred to the corresponding ESIC subjects.
