# PROCEDURE AND SUBMISSION DATE

New students may apply for one of the grants and financial assistance packages under the "Grants and Financial assistance for Study Plan" when they go through the admission process at ESIC BUSINESS & MARKETING SCHOOL. Candidates who are interested in applying for any of the plan's grants should apply to the Business School Admissions Dept. to obtain the relevant application form. Once completed, the form must be submitted, along with the corresponding documentation, either personally or by email, to the department of Business School Admissions.

## ▶ General Regulations on the Grant and Financial Assistance:

- New students may apply for only one of the grants under the plan. Grants are not accumulative; The most advantageous grant possible will be applied to each individual student. These grants are compatible with grants from the Ministry, in the case of these university master's degrees.
- When requested, the grant application form must be submitted to the Admissions Dept. of the Business School, depending on the particular type of grant.
- The grant application form must always be signed by the new student in the corresponding sections of the form, otherwise the document cannot be processed.
- Each grant has a different closing date for submission, so new students must pay particular attention to the dates stipulated in the descriptions (no grant application will be accepted outside these closing dates).
- The decision to award the grant will be communicated by ESIC individually, and on the dates set out in the descriptions of each of the grants. The decision of the Admission Committee is final.
- ESIC BUSINESS & MARKETING SCHOOL has a limited fund for grants and financial assistance for study. Rights are reserved, as regards adjudication of the number of these grants.
- The percentage of grant awarded, according to the type, will be applied to the cost of the tuition and not to the official fees or enrolment.

If you have any questions about the procedure, the documentation to provide, or the type of grant to apply for, do not hesitate to contact the Admissions Department.

# DIVERSITY GRANT

Aimed at national ESIC master's degree students. The amount of the grant will be applied to the cost of the tuition. Enrolment is exempt from discount.

## ► Requirements

- Candidates must successfully pass the ESIC BUSINESS & MARKETING SCHOOL admission process.
- Discrimination: the candidate must present documentation that justifies the situation of discrimination experienced.
- Functional diversity: the candidate must present a valid Disability Certificate (which lists the type and degree of disability).

## ► Benefits

- Candidates who have a disability equal to 33%, the amount of the grant will be up to 30% on tuition.\*
- For candidates who have a disability between 33% and 65%, the amount of the grant will cover up to 40% of tuition costs.\*
- For candidates who have a disability greater than 65%, the amount of the grant will cover up to 50% of tuition costs \*



## Documentation required for grant applications:

- Photocopy of DNI (national ID) / NIE (Foreign Resident Number) / Passport.
- Valid disability card and certificate of disability



## Where to submit documentation

All documentation should be submitted to the corresponding advisor simultaneously and scanned.



## Closing date for submission of documentation

At the same time as reserving your place, as indicated by the advisor.



## Decision

- The decision will be communicated by the Diversity Committee on the following dates:
- The first fortnight of September, for master's degrees which begin in September / October.
- The first week of February, for master's degrees that begin in February.

# WOMEN + LEADERSHIP GRANT

The diversity project run by ESIC Business & Marketing School supports the contribution of women to the professional environment and the professional world in general. We want to invest in female talent through the **woman + leadership grant**, specially designed for women with professional potential like you.

This is aimed at women who wish to pursue a Postgraduate course at ESIC in any of the following options:

- FULL-TIME MBA
- INTERNATIONAL MBA
- EXECUTIVE MBA
- GLOBAL MBA

The objective of this grant is that women with great potential and motivation can study one of the ESIC postgraduate courses mentioned above, on any of the campuses where they are given.

A 50% grant will be awarded for tuition (enrolment is exempt from discount) for each of the above-mentioned master's degrees. If one of the courses is cancelled, this may be transferred to one of the other two courses. This grant is national in scope.

## ► Requirements

Candidates must successfully pass the ESIC Business & Marketing School admission process.

- Academic record.
- Professional experience.
- Economic resources.
- Languages.
- Volunteering.





## Documentation required for grant applications:

- Notarised academic record with the grades obtained from all university courses taken.
- Curriculum Vitae, making special mention of the candidate's professional career.
- Last Personal Income Tax Declaration (IRPF in its Spanish acronym) and / or a current declaration of assets.
- Letter of motivation for doing the course.
- Letter of Admission to one of the afore-mentioned courses.

# EXPIGA GRANT, SOCIAL SECTOR



The EXPIGA Association, together with ESIC Business & Marketing School is now accepting applications from candidates for its grant to “boost professionals committed to the social sector”, for which it is granting a total of three grants for the following courses:

- 2 for the Master’s degree in Marketing and Sales Management (GESCO), and
- 1 for the Master’s degree in Corporate Communication Management (MCC).

Successful candidates must consider whether they meet the requirements of the Social Security Treasury Regulations to be able to do professional internships in a company.

## ► Purpose

- The objective of these grants is to train people who need to improve their training in the field of marketing and / or advertising communication and who are employed in social organizations (both in Spain and emerging countries) that work for peace and development of the most disadvantaged peoples.
- These grants are aimed at Spanish citizens or those who come from countries where educational opportunities are limited and who, after having received this training, can positively influence the development of their own society.
- The grant does not include living expenses or the cost of local transportation to ESIC.

## ► Including

- A 500€ travel bag towards travel from the grant recipient’s place of origin, if travelling from outside Spain. The beneficiary will access the “travel bag” once they have arrived in Spain.
- Help to obtain paid internships compatible with the master’s degree course, that can provide an extra income for students’ maintenance and period of stay.



## Documentation required for grant applications:

- Completed application form, to be obtained from the ESIC website, indicating the chosen master's degree. Click [here](#) to download the file.
- 2 passport-size photographs.
- Updated Curriculum Vitae.
- Copy of the academic record of studies completed.
- Letter of motivation on how people could positively influence society.
- Letter signed by the person in charge of the association / social institution where you are currently employed.
- Proof of sufficient income to reside in the city in question.
- For international applications, in addition to the transcripts, it is obligatory to submit a copy of the degree certificate.

# RECENT GRADUATE GRANT

Students who are enrolled in the last year of any of the degree courses taught by ESIC Business & Marketing School and who are going to take a master's degree as soon as they finish the last year of their degree, will obtain a discount on tuition for continuity of studies.

## ► Requirements

- Candidates must successfully pass the admission process for the Postgraduate area of ESIC Business & Marketing School.
- Not be in receipt of any other grant, or any discount from ESIC.

## ► Benefits

- The amount of the grant will be 40% of the amount of the tuition. Enrolment is excluded from discount.

# ICETEX GRANT

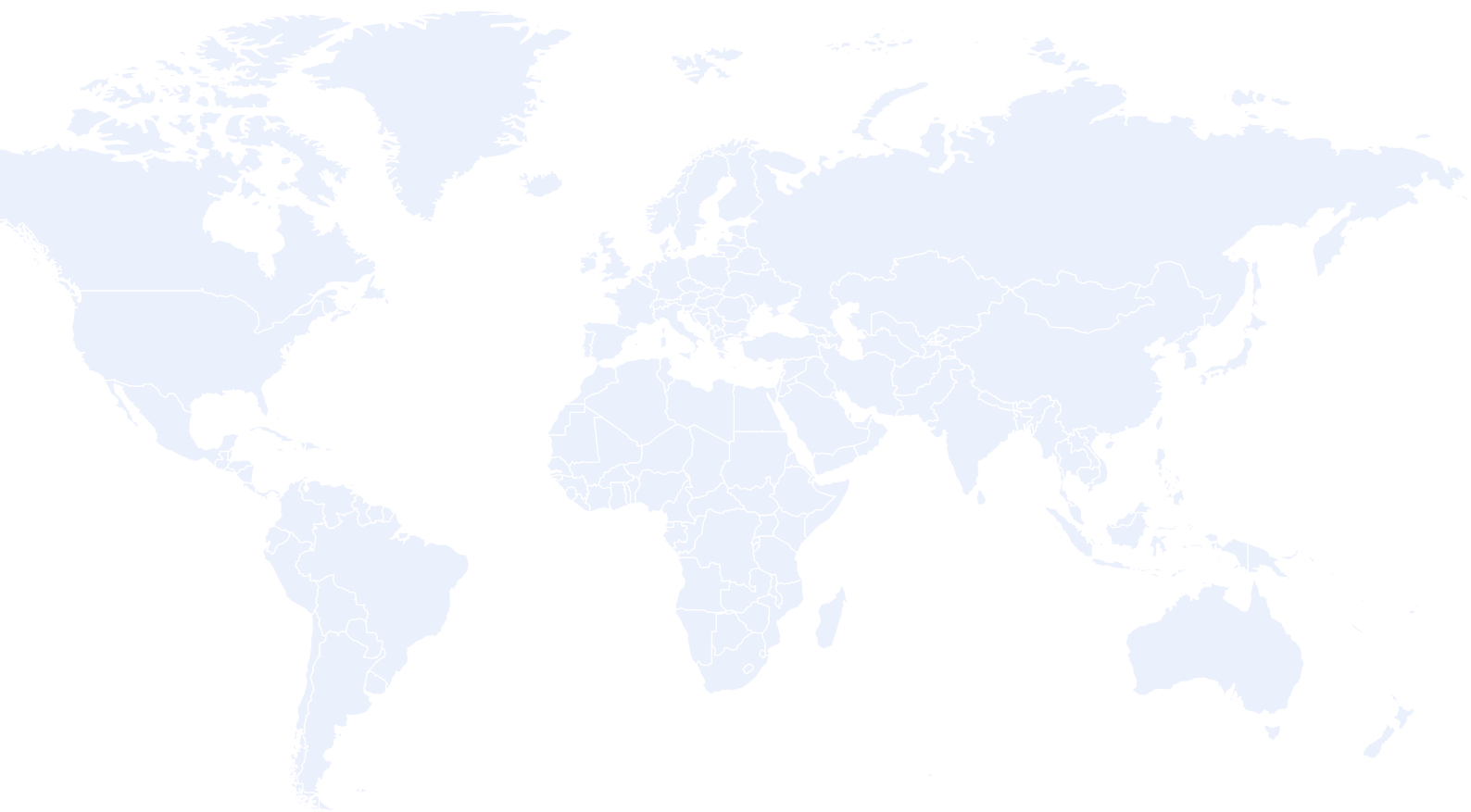


Through the Educational and Cultural Cooperation Agreement signed between ICETEX and ESIC Business & Marketing School, Colombian professionals are given the opportunity to obtain a 50% grant for the total cost of enrolment in one of the administrative fields indicated in this academic year.

The course is aimed at university professionals who have been admitted definitively or are far advanced in the process of admission to the chosen course.

## ► Requirements

- The candidate must be over 23 years old and under 60, have a minimum undergraduate average grade of 3.7 / 5.0 and possess at least 1 year of professional experience in the field of the course to be taken.





## ESIC Admission Procedure

The ESIC admission process must be completed.

- **5 PARTIAL 50% GRANTS. 5 grants of 50% will be granted, shared between the following courses:**
  - **MBA (Spanish)**
  - **International MBA (English) – 60% given in Madrid and 40% in Shanghai (China).**



## Preselection Criteria

- Current place of residence.
- Professional experience.
- Consistency between the applicant's profile and the course to be taken.
- Employment sector.
- Undergraduate Academic Average.
